## Albemarle County Fair - 2003

#### Bob, K4DU

The Albemarle Amateur Radio Club has obtained a 10x10 booth with power at the Albemarle County Fair. The fair attracts 30,000 people a year. The 2003 Albemarle County Fair's theme is "Sweet Home Albemarle". **The show runs from August 26<sup>th</sup> to August 31<sup>st</sup>**. The Fair grounds are just off of US 29 nine miles south of the 29 I-64 interchange. This is a tremendous opportunity to showcase Amateur Radio for our friends and neighbors.

The centerpiece of our plan is to have a station in the booth with VHF and HF capability and to use this station to pass traffic. Fair-goers will be encouraged to send a Radiogram to family and friends. We will also use the

booth to disseminate information about the hobby and promote our fall licensing classes.

**The club banner will be prominently displayed**. We will have the latest ARRL video running continuously and there will be handouts about the hobby, the club and the licensing classes. N4FWA has volunteered a HF antenna. I will provide a VHF-UHF antenna. We need rigs, power supplies and operators.

We will need to staff the station and have the booth set up at least an hour before opening. Concession and exhibit hours are:

## **Club Business**

### AARC Board Minutes July 8, 2003

Board Members Present: Steve KF4ZGD, Pete W4PRT, Ralph K4CFE, Marty AG4DN, Steve KD4HBX, Howard KG4TWQ, Bob K4DU. Members Absent: John KX4P.

Steve KF4ZGD opened the meeting at 6:35 PM

Committee Reports followed.

**Ralph K4CFE - Finance**: The finance report for the FYTD June 30, 2003 indicated Total revenues of \$2,627.01. Expenses indicated \$387.64 with excess revenues at \$2,239.37. Balances indicate AARC General Fund \$4,956.68; Repeater Fund \$1082.68; Packet Radio Fund 78.51; with a total of \$6118.87. Ralph indicated that club insurance should be coming due this month in the neighborhood of \$500. Marty indicated he had the bill and presented it to

Ralph for payment. (Complete copy of Income Statement available upon request to Club secretary.)

**Bob K4DU - Membership**: Individual letter inviting ex-club members and members who have not been participating in club activities were sent out inviting the group to attend Field Day. This was successful and did bring out numerous individuals.

**Dave K4DND - Techincal**: Steve KF4ZGD reported for Dave. The tone filters required for the 76 Repeater are no longer available. This is not an issue on the 925 Repeater. Overall the fact that these filters are no loner available has not degraded measurably the effectiveness of the Repeaters. The 220 repeater still presents a weak signal problem. The 440 Repeater will be relocated to the Marshall Manor site.

**Steve KD4HBX - Refreshments**: The total expenses for refreshments at Field came to \$110. The Board approved up to \$200 for refreshments for the Annual Picnic and Tail gate Hamfest in August without comment.

**Pete W4PRT - Activities**: A Field Day report will be coming out shortly. All were very pleased with the efforts and Pete indicated great appreciation for the efforts of the membership in making Field Day a success.

**Ben KG4QVP - Publications**: No report since Ben was out of town.

With committee reports completed Steve turned to the discussion of club participation in the Albermarle County Fair in August and September. Marty indicated that the \$1 million insurance coverage required to set up a booth would cost the club an additional \$50 over the current premium since we had an insurance policy already in effect. After discussion it was agreed to bring the matter before the membership at the General Meeting to follow. Pete indicated he would poll the membership as to how many were interested in obtaining Field Day T-shirts.

Steve addressed the necessity to name a new Club Trustee. Dave K4DND was discussed as being most qualified. No other names were submitted for consideration. Steve indicated he would bring the matter to a vote before the General Membership meeting.

There being no further business before the Board, Steve closed the Board meeting at 7:10 PM.

A motion was made to accept these individuals for membership, second and approved with no comment.

Dave K4DND introduced the guest speaker for the meeting, Carl Clements W4CAC, Section Manager ARRL for Virginia. He presented his background in amateur radio and a brief history of his advancement in the hobby. He stated clearly that one of his key objectives as Section Manager was to get out into the field and meet with as many clubs as he could and get to know the people that make up the hobby. He then covered the functions of Section Manager, the ARRL national organization down to the local level. He presented the various activities of the Field Organization such as Pubic Information, Official Observer, National Traffic Management, examinations, Official Relay Stations, Official Emergency Stations, Technical Coordination, Official Observer and lobbying at the national and state level to protect the interests of amateur radio. He also noted the ARRL Web Site as a source of valuable information on all aspects of the hobby. There followed a question and answer period. During this session he clearly made the point that he has always felt the primary function of a Section Manager was liaison to local organizations. When questioned about the difficulties in Richmond over which organization should have State recognition, he stated that many of the personalities involved in the dispute will have to be gone prior to any reconciliation. He did note that the Virginia EOC is now staffed by the Richmond Amateur Radio Club. There is no current Memorandum of Understanding between any state or national organization and The Virginia Department of Emergency Services. Carl was thanked warmly for his visit and departed with the thanks of the membership.

**Pete W4PRT - Programs**: On **August 14, 2003**, in place of the regular club meeting, the Annual AARC Picnic and Tailgate Hamfest will take place rain or shine at McIntire Park Shelter 1 at 6:00 PM. The program for the September meeting will be Neighborhood Watch. The programs for October, November and December are still pending.

Bob K4DU - Membership: See Board Minutes July 8, 2003

**Education**: Steve indicated that there will be a Fall Tech Class. More information will be forthcoming at the September meeting. He also indicated that there is a desire to hold a General Class session in the fall as well. He indicated an instructor was needed. He stated a notice would be placed in the Beacon for General Class instructors.

#### Dave K4DND - Technical: See Board Minutes July 8, 2003

**Steve KD4HBX - Refreshments**: \$200 approved for picnic refreshment by the Board. Steve was thanked by the membership for a job well done at Field Day.

**Pete W4PRT - Programs**: Steve presented Pete with an AARC Certificate of Appreciation for the fine job he did organizing and carrying out Field Day activities.

#### Old Business:

Steve presented the situation and problems if the club should desire to have a booth at the Albemarle County Fair. Marty indicated that the club insurance carrier only required \$50 additional to cover the required \$1 million liability insurance needed to set up a booth. Rick indicated his research into setting up a booth as well. After some discussion the membership voted to have a booth. Bob K4DU volunteered to be the project officer.

Steve noted another item of old business; did the club desire to obtain additional power poles for resale? The membership indicated by show of hands, yes. He would follow up. Pete requested those that desired Field Day T-shirts give him their name so he has an accurate count for ordering.

#### New Business:

Steve noted that Morris Jones had resigned as a Trustee for AARC and that a new Trustee needed to be named. He noted the action of the Board in nominating Dave K4DND to fill the vacancy. A motion was made and second to name Dave as an AARC Trustee. Dave was approved by the membership with no discussion.

Ernie W2EIU was placed in nomination to be AARC Public Information Officer. The motion was second and approved with no discussion.

There followed a raffle for a number of door prizes with proceeds going to the AARC.

There being no further business a motion was made to close the meeting. The motion was second and approved with no discussion. The meeting closed at 8:50 PM.

# ARRL Board Requests Policy Recommendations to Implement WRC-03 Results

#### ARRL Bulletin ARLB050

The ARRL Board of Directors has called on ARRL Chief Executive Officer David Sumner, K1ZZ, General Counsel Chris Imlay, W3KD, and the ARRL Executive Committee to develop ARRL policy recommendations for an FCC filing to implement the results of World Radiocommunication Conference 2003 (WRC-03). ARRL President Jim Haynie, W5JBP, chaired the July 18-19 Board session in Windsor, Connecticut.

"The League, as the Amateur Radio representative in the United States, will, through its democratic process, review input from its members as to the impact and implementation of these results to the Part 97 rules," a Board resolution declared. A report on the policy recommendations is due next January. The Board expressed gratitude to the IARU and ARRL WRC-03 team for its "tireless and dedicated efforts in promoting Amateur Radio" and congratulated it for achieving the IARU's goals at the month-long international conference, which wrapped up in Geneva July 4.

Delegates to WRC-03 reached a compromise on a 200-kHz worldwide allocation--7000 to 7200 kHz--effective in 2009, with no change to the existing 300-kHz allocation in the US or elsewhere in Region 2. The conference also eliminated the requirement that amateur applicants prove Morse code proficiency to operate below 30 MHz, leaving it up to individual administrations to retain or drop Morse as an exam element. WRC-03 decisions also resulted in changes affecting international third-party traffic, guidelines for standards of competence of amateur licensees, and recognition of the licenses of visiting amateurs.

The Board also implemented some recommendations of the wide-ranging Final Report of the Volunteer Resources Committee to the ARRL Board of Directors--an Evaluation of the ARRL's Field Organization. The committee, chaired by ARRL Midwest Division Director Wade Walstrom, W0EJ, concluded that the state of the ARRL Field Organization is "fair," but not sufficient to meet the League's obligation to provide emergency communications, especially at the national level.

In light of the report, the Board called for a comprehensive system to enhance the communications capabilities of the Amateur Radio Emergency Service (ARES). There are situations, the Board said--especially given the League's new Citizen Corps partnership with the Department of Homeland Security--when ARES "must have the capability to pass traffic across the nation quickly and accurately."

The Board also called on all 71 Section Emergency Coordinators to develop, implement and maintain a comprehensive Section Emergency Plan by year's end. Additionally, the Board asked Sumner to formally establish leadership training courses as a part of routine Section Manager orientation.

In response to the so-called "Minute 56" report initiated at last July's meeting, the Board voted to initiate a process to revise ARRL band plans for amateur allocations between 902 MHz and 24.25 GHz. "New band plans will be developed using as a goal the full amateur deployment of each band," the Board said. The Board voted unanimously to authorize President Haynie--with assistance from Imlay and Technical Relations Manager Paul Rinaldo, W4RI, "to explore specific terms of expanded partnering plans with the National Public Safety Telecommunications Council (NPSTC). Such cooperation could involve greater integration of amateur operation in the bands from 902 MHz to 24.25 GHz in public safety and homeland security communications."

Citing the Amateur Radio tradition of Elmering (mentoring) new and prospective amateurs, the Board okayed a resolution instructing the VRC to develop two or more viable options for an ARRL Volunteer Mentor program that would provide for "the promotion, support and growth of mentoring in Amateur Radio." The VRC is to present its options at the Board's January meeting.
