

### AARC Board Minutes December 14, 2004

Members Present: Pete W4PRT PRES; Bill AD6JV Acting VEEP; Marty AG4DN SECY; Ralph K4CFE TREAS; Steve KD4HBX; Bob K4DU. Members Absent: Howard W4UF; Jill KG4TFS; Ben KG4QVP.

The meeting was opened by Pete at 6:45 PM.

The first item on the agenda was a financial report by Ralph. This being his last meeting as Treasurer, he was thanked for his service to the club. The report for the period ending November 30, 2004 indicated in summary the following:

Ralph pointed out that membership dues did not cover expenses. Contributions of \$600.00 during the year enabled the club to complete the year with excess revenue. Bob, Treasurer Elect, indicated that this would be monitored closely in 2005.

John K14DJT, VEEP Elect, reported on programs for 2005. We will have our Annual Banquet January 9, 2005, 5:00 PM at the Ponderosa Steak House, Pantops. In February we will have a presentation on generators by Dave WG4T. In March there will be a presentation on slow scan TV by Kevin K4BDR. Pete noted that he would continue booking our current meeting room for 2005. Bob believed that a greater effort should be made to notify members that have not been attending meetings of the place a date/time of meetings. Action deferred, pending further discussion. Jay, K4AZV, Pres. Elect, asked why the club must have a presentation arranged for each meeting. He indicated that some meetings should consist of open discussion of items of interest, club activities, problems, etc. This will be considered next year.

Bob noted that Bob Dorsey W4RQ will be stepping down as VE Coordinator and he will be replacing him. Bob noted that he would make an effort to coordinate exams with other clubs, in order that Amateurs in the area will have a monthly opportunity to take exams.

The Board thanked Steve KD4HBX as he left the Board for the outstanding way he handled refreshments for club meetings and special events. He will be missed. A replacement must be found for him. There will be a call for a replacement(s) at the general club meeting.

Pete and Jay discussed the preparations that must be made for Field Day in June 2005. Options for location of the event and other necessary arrangements will be covered and reported to the membership.

From the floor Harry W2HD reminded the Board of a need to support the Amateur Radio NewsLine. A \$50.00 contribution was suggested and approved.

A general discussion followed addressing the need to raise funds during 2005 to preclude expenses out stripping income. Various methods were suggested and deferred to the new administration in 2005. A suggestion was made to combine the Packet Radio Fund with the Repeater Fund since no use has been made of the Packet Radio Fund for quite a while. Action was deferred.

With no further business a motion was made to close the Board Meeting at 7:10 PM, second and approved.

### Regular Meeting December 14, 2004

Pete opened the meeting at 7:30 PM. He called for the introduction of members and guests.

The presentation for the evening was made by Nancy Simmons and David Kostelnik representing the regional office of the MS Society. They thanked the club for its support of the MS Walk and the MS 150 Bike Race. Nancy explained the nature of the disability, what is being done in the research field where and how contributions are distributed. Their region covers 51 Virginia Counties. Funds are spent on education of care givers, those with the disability, treatment, research, to name a few areas of support. Dave reviewed the events that took place in 2004. There were 14 locations for the MS Walk. They raised \$282,000 of which \$30,000 was raised locally. The bike events had 500 participants and 100 volunteers. Again, he thanked the club for the excellent communication that was provided. He pointed out that participants feel secure and safe when they see the communications team out in the field. Without this assurance many would not participate. He noted that again in 2005 MS would come to the AARC and request support for the MS Walk and MS 150. He assured all volunteers that they would be well housed and fed. There followed a question and answer period. Pete thanked Dave and Nancy for their excellent presentation.

Pete took this opportunity to apologize for the long delay in the arrival of the hats and jackets. He assured the club he was actively pursuing a resolution of the problem.

Pete reviewed the financial statement. (See Board minutes)

Pete called for a round of applause for Steve and the excellent job he did for the club this past year as Refreshments Chairman. He noted the need for some one to replace Steve.

John covered the programs for 2005. (See Board minutes)

Tom W4RAE reported for the Education Committee. He noted the number that showed up for the VE test on November 20 and the number that passed.

Dave K4DND reported for the Tech Committee. The major effort has been to solve the noise problem on the 76 Repeater. He noted that he, Jay, Ron K4RKA, Hein N4FWA, Elmer KF4UCI worked on the repeater this past Sunday. He went on to explain the workings of a repeater and the components that could be causing the problems. He indicated that the problem possibly could be in the tuner or the antenna. He requested the club authorize the purchase of an antenna. He noted the cost at about \$170.00. A motion was made to approve the purchase, seconded and approved with no comment.

Pete reported to the general membership on the plans for Field Day 2005. (See Board minutes)

Dave K4DND informed the club of the advantages of belonging to The Repeater Association. He distributed applications for individuals who desired to become members.

Bob K4DU reported on the BPL testing by the club and the Electric Cooperative in Nelson County. He thanked the many club members who assisted in the effort. He noted that there was interference on a number of bands. Some public safety bands were also impacted. The Electric Coop is working on many bands at this time and will continue testing its system. Jay indicated that this was a public awareness issue as well as a technical one. We must use a measured approach in the media as well as take a regional view involving the Emergency Coordinators from adjoining counties.

Pete called for approval of the November minutes as they appeared in the December Beacon. A motion was made, seconded and approved with no changes.

This concluded the business for the evening. Pete called for a motion to close the meeting. A motion was made, seconded and approved with no comment at 8:45 PM.

## Packet Standards ... Revisited

1. **Deviation** is defined as the instantaneous change in frequency with a given input signal, or the peak value of the carrier departure from center. The FCC defines Narrow Band FM as 1.8 kHz deviation. This seems to correspond with my observations of on the air signals that are showing values of 3 to 4 kHz. p to p. Most of the transmitters that I have observed have their limiters set to about 2.0 to 2.5 kHz. The G.E. Royal Execs that are modified for the Ham bands are nominally set for 4.5 kHz with limiters at 5.0 kHz. This is compatible with the receiver's bandwidth of about 20 kHz. The discriminator is quite linear over this range and it is DC coupled through a 100k resistor to a test point and in the WA4TFZ 145.61/145.01 unit is available on a terminal strip. This is an excellent point to monitor with a scope since no de-emphasis is present. (use a low cap. probe). The transmitter audio is pre-emphasized the normal 6db per octave between 300 and 3000 Hz. The receiver audio is de-emphasized.

2. **Modulation Index and receiver bandwidth.**

**Modulation Index** is defined as Deviation divided by the modulating frequency. With the deviation set to 1.8 kHz, the index is 1.5 for the 1200 Hz low tone and 0.82 for the 2200 Hz high tone. Examination of the Bessel functions shows the need to include the 2nd order sidebands in the receiver's passband. This requires at least  $4 \times 2.2 = 8.8$  kHz bandwidth. Most of the ham radios are at least this wide and some are

over 20 kHz. The need for the wider bandwidths is to accommodate the difference in frequency settings of both transmitters and receivers caused by aging and temperature on xtals. The compromise here is obvious. The higher sensitivity receiver usually has the narrower bandwidth and requires greater attention to frequency tolerance and deviation.

### 3. Pre-emphasis, De-emphasis:

The use of pre-emphasis of the transmitted audio stems from the desire to improve the S/N ratio of the high modulation frequencies by de-emphasis of the receiver discriminator output. This works with wide deviation fm and multiple tones. Neither is the case for packet and no improvement is provided.

### 4. Conclusions and Recommendations:

In view of all the above, it appears best to transmit equal deviation signals on the air. Local users and PBBS settings should keep deviation settings below the 1.8 kHz level. For Backbone systems, careful attention to frequency and higher deviations should be used to improve throughput seems to be a desirable goal.

### 5. Measurement of Deviation:

For those Hams who have access to Service Monitors or Spectrum Analyzers, checking deviation is easy. For those who do not, the task can be more difficult. A very good check can be done with the aid of an all mode receiver.

a. Set the packet transmitter to a locally unused frequency and set the TNC to CALIBRATE. Use a dummy load on the TX if possible.

b. Set the receiver in the CW mode and tune for an audible beat note of about 500-600 Hz with no modulation on the packet transmitter.

c. Turn on the high tone (2200 Hz) and adjust the tnc level until the beat note is minimized. The modulation index when the carrier is nulled is 2.4 (Bessel J0). With the 2200 Hz tone, this gives a deviation of  $2.4 * 2.2 = 5.28$  kHz. Using the 1200 Hz tone and the same procedure, the deviation is 2.88 kHz. Do not forget to include the effect of pre-emphasis on the tx audio if present. Setting the deviation by backing off the 2200 tone amplitude to one half will give a deviation of less than 3.0 kHz, about right for local use.

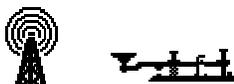
