The 146.760 Repeater and the 444.250 Repeater are both back on the air. Both were reactivated at their new location on May 20th.

Moving the 440 repeater from its temporary location at Hein's (N4FWA) residence, Hein, Dave (K4DND), Greg (N4PGS) and Dick (K4BZW) placed the 440 repeater at the new Bucks Elbow Mountain location during the afternoon. A number of Hams started running tests to determine the propagation to their location. Over time we will gain a better idea of the repeater's coverage. SHOULD WE BE TEACHING...

A course in on-the-air ethics? That is NOT a question for AARC or CHO-ville hams to answer! With very little doubt, the Radio Amateurs in this area are among the most polite and caring Hams I have ever encountered. However, please read on.

At the recent Dayton Hamvention, the FCC's Riley Hollingsworth, K4ZDH, exhorted a standing-room-only crowd to "read over the Part 97 rules covering the Basis and Purpose of Amateur Radio" and to operate as if youngsters and overseas stations might be listening to our transmissions. He went on to state that the hobby doesn't always present its best face to the world. He continued by saying that hams need to understand that demand for HF spectrum in many countries outside the U.S. is increasing. Quoting, "Too many in our service take the allocations for granted. Some of the Third World countries would love to have 75 meters as a national telephone system." What does transpire on some amateur frequencies is often an international embarrassment, says Hollingsworth.

You may consider this to be a problem of the late '90's as we are awaiting the new millennium and the moral characteristics of our societies seem to be taking a turn for the worst. However, let me state that in our preparations for WARC-79, the last big world conference on the radio spectrum, I was going about our 50 States preaching care of our HF assignments and VHF/UHF, too. That was more than 20 years ago and the problems existed then, also.

Some Radio Amateurs think that our "freedom of speech" laws allow anything to be stated at anytime and anyplace. There's probably some truth in that understanding and the Supreme Court might very well

uphold that freedom on our Amateur Radio frequencies. Even though this is a fundamental part of our way of life, is this any reason to jeopardize our frequency allocations?

Given that question, it is this writer's opinion that most Hams would opt for tighter lips and protect our future in that manner. It is necessary to understand that at the International Frequency Conferences the one nation... one vote... is the rule. It makes little difference that our vast Nation needs many, many times the frequency spectrum to meet our needs than does the newly-emerging nation.

As the saying goes, we must remain the "squeaky clean" Hams of the world so that other nations will support our needs without a critical look at the "vast wasteland" that sometimes is obvious by the negative criticisms coming forth from U.S. Hams.

Please don't take these words as a censoring of our freedoms. Our licenses grant us privileges, but with those privileges comes the need to exercise responsibility. CHO-ville Hams need not worry because we DO exercise responsibility. Keep up the good work!

* Reminder--ARRL Outgoing QSL Service fees have changed: League members are reminded that the ARRL Outgoing QSL Service fee schedule was revised effective January 1, 1999. The current fees are \$6 per pound (or portion of a pound), \$1 for 10 cards, \$2 for 11-20 cards, and \$3 for 21-30 cards.

Packages accompanied by the incorrect fee will be processed, but senders will be billed for the additional fee. Priority will be given to packages with the correct fee enclosed. "PACKET"

Grayson...KF4FYI

As everyone probably knows, I really don't know a lot about PACKET. But, what I do know, I would like to pass on to those who don't know anything about it. To me, when I first learned of PACKET, I was a little skeptical about how much good it would do the HAM community. Well, I changed my mind after seeing a few disasters around the country. When all else fails, there is always PACKET.

I'm not really sure exactly how these little TNCs take the characters and pack them into 128 bytes-of-information and send them over the air on radio waves. These are called digital transmissions.

Then, the receiver picks them up and the TNC transforms these digital signals back into usable information and then sends them to the screen of the computer as text.

Another thing, TNCs can do other things such as: operate in conjunction with a computer as a Packet Bulletin Board System (PBBS). These operate as a forwarding system to other TNC's, plus they permit operating "keyboard to keyboard" with other operators.

What is required to set up a PACKET system?

There are four items that are needed to make a complete system. First, you need a computer with a good packet program. Just about any computer will do and a program such as Yapp, Hamcom, ARES, etc. Second, you will need a TNC. The one I use is an AEA PK 232 with a communication cable to connect it to the computer. Third, you will need a good transceiver, preferably a 5 to 10 watts output and any required cables. Last but not least, a very good antenna system. I use a dual band J-pole with a 4.7 db gain, purchased from Arrow Antenna in Colorado.

The next thing on the agenda is learning to operate the system. This will be fairly easy as the TNC manual will give you all of the standard commands that are used to control the system.

Now, A few words concerning emergency use.

In case of an emergency such as a power failure, etc., most TNC's have a base voltage of 12 volts. Most small transceivers or HT's can be operated on 12 volts. Now, there is the problem of the computer. If you are using a computer that requires 110 volts, then a generator will be a handy thing to have. However, there is an option. A lot of the laptop computers operate on 6 or 12 volts.

The option of using a laptop computer means there is no need for a generator, except for other uses. Now, you can operate your complete PACKET station from your vehicle or use separate 12 volt auto or deep cycle batteries, that can be placed anywhere. They also are movable at a moments notice.

The use of PACKET is especially useful when there is too much noise in the atmosphere for voice transmissions. Any digital signal can usually be pulled out of any noise level. This is one of the main reasons why PACKET was developed. To take the place of voice transmissions that required more power to transmit for a minimal distance. Digital signals travel further on less power and are more readable in a high noise area.

In times of emergency, such as power outages, loss of telephones and in the unlikely event, as most people think, of a war in this country, PACKET might be the most needed equipment that we have. Amateur Operators will probably be the only ones to have such equipment. Therefore, the Amateur Operator is one of the most valuable asset this country has. In peace time or war time.

P.S. c-mon guys. Lets get some PACKET stations set up around here.

What is it about hearing "5 x 9" that elates us so? Are we so insecure that we need this reinforcement to our egos? It has to be more than just the pleasure of reassurance that our equipment is in working order.

During the exercise on the Thursday night net a couple of weeks back, the net control (Brad) asked each of us to back our power down to the low setting, to see how we were copied at his location. When he got to K4RKA, that smart-alec, RON, pointed out that he WAS on low power, ALL ALONG, where all of us should have been.

We are constrained by the rules of our craft to use the LOWEST POWER that will permit us to be understood by our correspondent.

When we are contesting, or trying to break through a pile-up to a rare DX, is the only excuse for running at full power.

If, when initiating a QSO, we hear, "five by nine," our response should be, "If you're not just humoring me, let me back off on the power and see if you still copy Q-5." It is true, of course, that sometimes "five by nine" is just a routine response. Which it shouldn't be. And if you hear "Twenty over," your response should be, "Oh, I'm sorry! Let me reduce power by half, and see if you still copy."

DISASTER PREPAREDNESS**Richard, K8EV**

Another Field Day! Great! But shouldn't we be doing something to prepare for a REAL national disaster? Don't get me wrong, I LOVE field day! Not only does it make us drag out the deep-cycle batteries, the generators, the antenna wire and the solar chargers, but it's also great fun.

And it lets people try new things. My first Field Day was way back when Bob, K4DU was president. I volunteered to help with setting up and dismantling, and got to learn about shooting lines over branches to put up dipoles.

Since we were, in those days, eligible to

operate at the novice-tech station, I sat in with Bill H. and Greg, and learned a lot about protocol and procedures, and antenna tuners and other great equipment I'd never seen before.

And at the old-timers' tent, I was even allowed to make a few contacts on 20 METERS, where I doubted I'd ever have privileges on my own. I recall listening to the pure music of John Gray's fist on the QRP rig.

A couple of years later, I remember BRIBING the wife of the then-president to make her FIRST QSO. She had just gotten her ticket, but mike-fright prevented her from making a contact. I had to up the ante to a pound of Costa Rican dark roast coffee to get her to make the plunge. After that, of course, it was hard for her OM to get the mike away from her. A couple more years later, a couple of other hams and myself decided we'd strike out on our own, and operate a station up on the Blue Ridge Parkway. Talking on 2 meters to the group at the fire station, we were feeling pretty smug, because they were sweltering under a heat wave, and we were enjoying the cool breezes at our extreme elevation. By the time dawn arrived, however, the temperature had dropped to something ridiculous in the month of June, a brisk wind had picked up, and it started to drizzle. Lucky for us, my daughter and her husband showed up at daybreak and built a fire to thaw us out. And my daughter relieved me at the mike and got a pile-up going. JUST for being a YL.

Great fun, great preparedness training, and great PR for the club, (thanks to Ernie, in recent years), and for Amateur Radio nationally. But I can't help thinking that we really need an unannounced preparedness exercise. Like the PHONE TREE a couple of weeks back.

Let's set this up for the whole country. A Y2K disaster simulation: Make sure all repeaters have battery back-up. Assign blocks of frequencies to each area, and appoint net-control stations, with authority to assign frequencies in their block to local stations. I haven't thought this through, of course, but I'd like to plant the idea, and perhaps somebody in maybe the ARRL

could develop it before it's disaster time. Y2K IS COMING, and even sooner, a bumper crop of hurricanes is expected this season. HAM RADIO SHOULD BE READY.


