A Few Words about the Pledge

At the October Meeting of the AARC a motion was made that we begin each meeting with the Pledge of Allegiance. After a brief and somewhat uncomfortable discussion the motion passed. In the days following that decision I have had some second thoughts.

Let me begin by saying that this is not a matter of patriotism. I believe that all members of the AARC love their country. Many, if not most of us have served our nation in time of war and in peace. I have several concerns. But first, a little background.

The Pledge was written by a Baptist Minister and Christian Socialist Francis Bellamy in 1922. It has been modified several times and was not recognized officially by the US government until 1942. The words "under God" were added in 1952 during the Eisenhower administration. The pledge was intended to instill love for country and for the principles upon which it was established (values in the Declaration of Independence, the Constitution and the Bill of Rights) in the minds of youth. This was at a time when nationalist movements were rising all across the globe. For most of the history of our republic we did not have a pledge of allegiance.

The pledge is used in opening ceremonies in schools, government and some private organizations. The arguments made in our meeting supporting the recitation of the pledge were:

- 1. Other Radio Clubs start their meetings this way.
- 2. We are an organization that serves the public

The AARC has been recognized as one of the best radio clubs in the world by the Dayton Hamvention. We have been around for 50 years without using the Pledge of Allegiance to start our meetings. I believe that our recognition came in part because the club and its members exemplify the qualities articulated in Paul Segal's "The Amateurs Code". The sixth item in that code says "The Amateur is Patriotic – His knowledge, and his station are always ready for the service of his country and his community."

The problem with oaths and creeds is that a person can repeat them so often that they lose the meaning of the words. If you want an example of this think about how well the officials of our Federal Government are doing on "defending and protecting the constitution". From where I sit it seems that to some these are just nice words that one says in a ceremony before assuming office. Please believe me that I am not trying to be political. I am simply saying that actions are far more important than words and integrity only exists when there is a match between the two. I would rather that the club be known by its actions than any ceremony that it chooses to do or not to do.

Some people have religious restraints against swearing pledges and oaths. I fear we live in times where people fail to understand the power of words to bind and words to damage. We should take much greater care in our choice of words. If someone failed to say the oath at the beginning of a meeting would he or she be criticized or feel out of place? Also the AARC has members who are citizens of other nations; what do they do or say when the pledge is performed?

We are a radio club, focused on improving our knowledge and skill in the radio art, promoting amateur radio and using our stations and skills for our enjoyment and the benefit of others. My personal feeling is that the pledge of allegiance is as appropriate for the AARC as it is at Aunt Mary's Bridge Club. But the more important question is what do you think? Perhaps a motion to reconsider the vote at the next meeting would be one approach?

The Pledge of Allegiance Controversy

During the October 2013 meeting of the Albemarle Amateur Radio Club, member John Underwood, K4EBS, made a motion to add the Pledge of Allegiance to the beginning routine of each club meeting. John's motion stated, "I move we (the Albemarle Amateur Radio Club) open each meeting with the Pledge of Allegiance of the United States."

While on the surface, John's motion sounded like a motherhood and apple pie issue, John's motion ignited a firestorm of controversy! Some members were strongly in favor, some strongly opposed, and many were neutral. At least one member threatened to leave the club if this motion passed. Clearly, this issue needed further examination.

John's stated his motives and rational for making his motion, that he belongs to other organizations where meetings are always begun with a Pledge of Allegiance. Thus, he thought it to be only natural that the AARC do the same. (John served for seven years as a U.S. Navy submarine officer and has been a licensed ham since 1955. His web site is www.k4ebs.com.)

A majority attending voted in favor of the motion, but a vocal minority opposed the motion. However, only about 30 members were present at this meeting to vote on this unexpected motion. AARC currently has 157 total

members. So this important motion was passed by only about 20% of our total membership.

Those opposing the motion described the pledge as a political and a religious statement. They expressed a view that the AARC ought to remain a place free from politics and religion. They expressed an opinion favoring their First Amendment freedom of speech rights, which includes the right NOT to be required in public to make a political and religious pledge.

So, what are the practical implications of requiring the Pledge of allegiance to be used at the opening of each meeting?

First, there would be a practical mechanical problem, that the AARC purchase a flag and flag pole and that someone be responsible to bring the flag and its pole to each meeting, then lugging it back home. This could quickly become a burden. And there was no follow up motion to provide money from our treasury for the purchase of a flag and flag pole.

On the pro side, adding this new ritual at the beginning of each club meeting might bring a sense of patriotism and unity to each meeting.

But, continuing the con side, some members viewed this proposal as adding one more government intrusion into our already over regulated lives.

Just what does the pledge say and what was its intended purpose?

The Pledge of Allegiance was written in August 1892 by Francis Bellamy, a Baptist minister and Christian Socialist. The Pledge was first published in a children's magazine as part of a national celebration of Columbus Day. Wikipedia states that the pledge was part of a marketing campaign to sell flags to schools and to instill national loyalty in young minds.

The Pledge of Allegiance was adopted by Congress in 1942 to promote nationalism during WWII and has been modified four times since its composition. Currently the Pledge of Allegiance reads: "I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all."

Leading the opposition to John's motion was Dennis K4THE. (Dennis served as an U.S. Army Signal Corps officer during the U.S War in Vietnam.) Dennis viewed the motion as a loss of freedom by AARC members. Dennis stated that he felt the club ought to remain a place free from politics and religion.

To be opposed to a public reciting the Pledge of Allegiance should not make that person suspect as unpatriotic or as Un-American. Some members prefer privacy for their political views.

Since this proposal turned out to be such a sensitive issue, perhaps the entire club membership ought to vote on this significant change in meeting procedures.

What's your opinion? Be bold, be brave; state your opinion and submit it for discussion at the next meeting.

Our personal thanks to Dave Damon K4DND and Bill Pond NØWP for their enthusiastic guidance and support in making our Greene County club a reality.



Don N4UVA presented a discussion concerning the Awards Banquet in December. The date was confirmed as Tuesday, December 10. He announced that this would be a waiter/waitress served dinner (No Buffet) and it was approved that the per person ticket price be \$25 and that the club would cover guests, taxes and gratuity.

The details were approved on a motion by Dennis K4THE that was seconded by AJ KE4AJM. The vote was unanimous.

A motion was made by John K4EBS with the statement, "I move we (the Albemarle Amateur Radio Club) open each meeting with the Pledge of Allegiance of the United States." The motion was seconded by Joe W2PVY and following a short discussion, the motion passed by a majority vote with 30 members present. There were approximately 5 members voting no.

The meeting adjourned at 2104 hours.
