have a K###. There are 2 groups, activators who setup park station and hunters who try to contact them. Activators send in automated logs to ARRL. Use URL https://pota.app/#/ to get to POTA app. Jim gave demo of app features. Uses N3FJP logging software. POTA is like a contest that started in 2014 and never ended. A typical QSO is similar in format to Field Day. Jim has worked most POTA stations with 100 watts power. Activators often use car mobile station and use a tree antenna. URL link to Jim's
